Have entered into an agreement on the following matters:

TEAM MEMBERSHIP OF PLAYER

The Following Rights and Privileges are the matters of value the player has bargained for in this agreement; any additional privileges afforded player are not included in this agreement unless done so in writing.

- PLAYER, by signing this agreement, shall become a roster member of TEAM for the duration of one (1) calendar year commencing on the date of execution of this agreement.
- PLAYER shall be listed as a roster member of TEAM in all official publications by TEAM.
- PLAYER shall have the right to inform third parties that they are a member of the team, and have a right to access all TEAM practices and gatherings unless otherwise prohibited in this agreement.
- PLAYER shall have the right to play as a member of the TEAM in a manner determined by the head coach of the TEAM. PLAYER, unless prohibited by the code of conduct, shall ALWAYS have the right to suit of for a game, unless overriding equipment issues prevent such action.
- PLAYER shall have the right to practice as a member of the TEAM.

PLAYER RIGHTS GRANTED TO TEAM

- PLAYER grants TEAM perpetual rights and license in regard to PLAYER'S likeness, name, and all other rights currently held by player for any and all legal purposes TEAM may choose to utilize. PLAYER shall not have these rights separate from TEAM. The rights include, but are not limited to:
 1. Sale of merchandise related to player's likeness
 2. Usage of Player's name or likeness for purposes of advertisement
 3. Sale of entertainment rights of PLAYERSale of rights to this contract
- PLAYER agrees that they may not be a member of any other team; in any league or level of football, during the 2009 season **without the signature of release from the owner or general manager of the TEAM.**
- PLAYER agrees that they may be dismissed from the roster of TEAM and agree to be banned from the LCFL (Labelle Community Football League) participation if they are discovered to be participating in another team during the term of this contract without having received a release from TEAM. The determination to dismiss and ban PLAYER shall be exclusive to TEAM.
- PLAYER agrees to show up to practice at the assigned places and times unless otherwise excused by TEAM staff.
- PLAYER agrees to appear at events and games in a timely manner and in a prepared state unless otherwise excused by TEAM staff.

CONDITIONS TO PLAYER MEMBERSHIP STATUS

PLAYER, AS A CONDITION OF MEMBERSHIP TO THE TEAM, AGREES TO THE FOLLOWING:

1. All team fees must be paid before May 1st. This fee is \$ _____ for all TEAM members. The following schedule of payments must be met:

2. If PLAYER decides to quit after paying their fees, said fees will not be refunded.

3. If PLAYER wishes his release to play for another team, all his fees must be paid before a release will be granted.

PLAYER agrees to be bound by the terms and regulations of the LCFL (Labelle Community Football League or other league as TEAM determines and gives notice to player and player shall be subject to all said leagues bylaws. Player specifically acknowledges the LCFL as a third party beneficiary of this agreement.

5. PLAYER will maintain a drug, alcohol and smoke free environment at all practices, TEAM and on the game field. SEE CODE OF CONDUCT FOR DISCIPLINE – POSTED ON THE WEBSITE AND PREVIOUSLY GIVEN TO PLAYER

6. PLAYER will play any position assigned and do their best for the team.

7. PLAYER agrees to abide by all decisions of game officials, coaches and management of TEAM. PLAYER will not create any unsportsmanlike gestures or make any inappropriate comments

8. PLAYER will not in any way damage or deface property, buildings and/or equipment.

9. PLAYER agrees that they will remain a member of the _____ organization until released or this contract expires.

10. PLAYER agrees to return any uniform and/or equipment in good working condition as when except for normal wear and tear, unless directed otherwise by the management of the TEAM. Failure to do so by one week following the end of the season or upon release from the team shall result in an automatic fine of \$100.00.

11. PLAYER agrees to be at all practices unless given permission from the Owner, General Manager Coach of TEAM. SEE CODE OF CONDUCT FOR DISCIPLINE PREVIOUSLY GIVEN TO PLAYER

12. PLAYER shall be bound by strict confidence from divulging any TEAM information of any parties. Said information specifically includes, but is not limited to: TEAM playbooks, health status of roster members, financial information of TEAM, recruiting efforts by TEAM, standing status of other players of TEAM, or any other information learned by PLAYER as a result membership of TEAM which could be used to give third parties advantages in any way against TEAM.

13. PLAYER agrees that violation of any of the above conditions may subject him to suspension membership privileges of the TEAM or Release by the TEAM. PLAYER specifically understands agrees that any such determination of condition violation shall be made by TEAM by its own DRUG POLICY As a member of the TEAM, PLAYER agrees, that they will be free of illegal use of drugs and violation of this team rule will result in immediate and indefinite dismissal from the team.

14. Player specifically and knowingly acknowledges their willingness to abide by all the aspects of the LCFL and TEAM Player Conduct Codes – previously received by Player and herein incorporated into this agreement in its entirety. Said Code is published on the LCFL website.
